1) STYLE OF QUOTATION: TWO PART SINGLE STAGE SYSTEM

Bidders who are not meeting the pre-qualification criteria and not confirming all NIT Terms & Condition in part-1, their offer will be rejected and their price part shall not be opened. 2) PQC (Pre - Qualification Criteria):

- a) The bidder be Manufacture/authorized dealer/distributor of M/s. Nord drives systems Ltd. Supporting documents to be submitted along with offer, failing which offer will not accepted.
- b) Bidder must have executed purchase orders of "NORD" make motors. Supporting documents to be submitted, failing which offer will be rejected.
- c) Bidder should confirm submission test certificate along with material, failing which offer will be rejected.
- d) Offers received without EMD and tender fee will not be considered. However MSME/Small scale industries are exempted from submission of tender fee and EMD against submission of current valid registration certificate issued by state (or) central government.

3). - 15). FIRM PRICE:** The price should be firm till execution of entire order quantity.
- 16) PAYMENT TERMS:** Confirm acceptance of our standard payment term of within 30 days from the Date of receipt and acceptance of material at our Tummalapalle stores.
- 17) VALIDITY:** The offer should remain valid for 90 days from the date of opening of the tender.
- 18) Sample:** sample, if called for, shall be submitted free of all charges and same may not returned to the tenderer.
