Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. - 3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

## 9. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

## 10. Inspection

**Guarantee / Warranty:** The tyres should be guaranteed / warranted in terms of minimum running hours of 500 hour of operation or 12 months from the date of receipt and acceptance of material at our Stores, whichever is earlier against manufacturing defects excluding abnormal failures such as operation / mainten ance faults conditions such as presence of water, side cuts, piercing by material other than the mine ore / waste.

**Pro-rata Penalty:** In case the life obtained of the tyre is lower than the guaran teed life as mentioned above, a penalty amount will be deducted on pro-rata ba sis. Pro-rata penalty amount will be calculated on proportionate basis as per for mula below:

Pro-rata penalty formula = (B/A)xC

Where,

A = Original Tread depth of the tyre

B = Remaining tread depth at the time of failure of tyre

C= Cost of the tyre

Life of the tyres will be monitored and reports of life of tyre will be jointly prepar ed and signed by both in-charge of UCIL Mines and supplier's representative. Th is report will be the basis for penalty deduction, if any. **Related party clause**: Subsequent to bid opening, if it is found that bids subm itted by related parties in which there seems to be collusion are liable to be reje cted. Parties are considered to be related if one party has ability to control the other party or exercise significant influence over the other party in making finan cial and / or operating decision.
