- i) Unloading of the material shall be done by the supplier at Turamdih Mill as per the instruction of S ection In-Charge (Mill).
- ii) Before unloading, a sample shall be collected in an air-tight 500 ml bottle and sent to UCIL laborat ory for analysis along with the tag of the Invoice Number and Date.
- iii) The tanker shall be unloaded only after the UCIL lab result.
- iv) No re-sampling or re-analysis shall be entertained.
- v) Analysis report of UCIL laboratory shall be treated as final and binding for the sample collected at the time of unloading.
- vi) 0.5 and above % will be rounded off to the next integer. Example: 49.5 % shall be considered as 50% & 49.4% shall be treated as 49%.
- 13) Any document required during submission of bid wherever mentioned in the bid &/or after placement of P.O., shall be sent through speed post only to the proper address as mention ed in the bid/P.O. only.

14) DISPUTE RESOLUTION MECHANISM AND JURISDICTION:

- a. **CONCILIATION**: Notwithstanding anything contained in this contract, any disputes or differences whatsoever, which are to be settled amicably between the parties with their authorized representatives, shall be resolved through conciliation.
- b. **MEDIATION**: Any disputes or differences, which are not settled amicably through conciliati on, then either of the parties, may approach for mediation to settle under mediation Act, 2 023. The procedure is to be followed as prescribed in the Mediation Act, 2023 amended from time to time.
- c. **AMRCD**: Any disputes or differences between the parties are not settled amicably with con ciliation and/or Mediation, then such disputes or differences shall be resolved through Ad ministrative Mechanism for Resolution of CPSEs Disputes (AMRCD). Any disputes or differences relating to interpretation and application of the provisions of commercial contract(s) between Central Public Sector Enterprises (CPSEs) / Port Trusts, inter-se and also between CPSE(s) and Government Department(s) / Organization(s) shall be taken by either party for its resolution through AMRCD.
- d. **ARBITRATION**: Any disputes pr differences where clause no. (c) is not applicable, the part ies may go for arbitration as per the provisions of Arbitration & conciliation Act, 1996 provi ded the disputes is restricted to less than Rs. 10 cr. (Ten Crores). This amount is with refer ence to the value of the dispute and not the value of the contract which may be much high er. In all other cases, arbitration shall not be a method of dispute resolution arising out of t his contract.
- e. **JURISDICTION**: If the matter is not resolved through above means, the dispute shall be re solved in civil court of law at Jharkhand only.

Note:

1) Material is required to be supplied on FOR-destination basis duly unloaded & insured basis.

- 2) As staggered delivery schedule and Pro-rate deduction clause given in the bid document, hence offlin e calculation of LD and pro-rata penalty will be done by Paying authority during the time of making payment to the supplier.
- 3) PUC certificate of Pollution Control, if applicable should be submitted along with the supply of materia ls.
