1. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. 1. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

3. Certificates

The bidder is required to upload, along with the bid, all relevant certificates such as BIS licence, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.

1. Bidder must be either OEM or authorized dealer of the product offered. The authorized dealer must submit the valid authorization certificate of OEM along with bid without which bid will be summarily rejected.

3. **Supply Validity of Cement (Period of Contract):** Cement will be supplied as and when required quantity basis on firm price during the period of 18 months from the date of contract. Hence Period of contract will be 18 months from the date of contract. Supply validity may be further extended if required on mutual consent. However buyer reserves the right to postpone schedule of material supply after finalization of order or completion of contract period and extend the contract by further 06 (Six) months without any additional cost implication.
4. **Delivery Schedule:** Delivery is required on 'As and when required basis' Within 07 days of issue of delivery advise. Accordingly Cement will be supplied on as and when required quantity basis within 07 days from the date of receipt of written intimation/delivery advise from concerned store/Consignee. In case cement will not be supplied as and when required quantity basis with 07 days of intimation/delivery advise then penalty as per GEM contract terms and conditions will be applicable.
5. **Transportation:** Supplier will be completely responsible for transportation, Insurance, loading, Unloading & stacking of product at our store. All charges for this come under the supplier's scope.
6. **Manufacturer Test Certificate:** Cement will be supplied along with manufacturer test certificate for each consignment and testing should be done as per latest version of IS Code.
7. **Inspection:** We reserve the right of inspection and acceptance of cement after its delivery. This is not withstanding your furnishing of test certificate.
8. **Testing of Cement from NABL approved Lab for cement testing:** Test report shall be submitted by the supplier from NABL approved laboratory as and when required by UCIL's competent authority/ HOD (Civil) during the tenure of contract for their supplied consignment/materials. Subsequent to receipt of written intimation from UCIL's competent authority/ HOD (Civil) about testing of cement from NABL approved laboratory against their recent supplied materials to UCIL, supplier shall collect the sample and after packing, the sample will be submitted to NABL approved laboratory and after completion of testing by LAB, report will be submitted to HOD (Civil) at the earliest. Approximate number of sample will be 06 (Six) during contract period. All the costs of sample collection, packing, transportation and testing till the submission of testing report will be borne by the supplier. In case testing result will not meet the relevant IS Standards then available material of respective consignment will immediately be replaced by the supplier at free of cost.
9. **Related Party Clause:** Subsequent to bid opening, if it is found that bids submitted by related parties in which there seems to be collusion are liable to be rejected. Parties are considered to be related if one party has the ability to control the other party or exercise significant influence over the other party in making financial and / or operating decision.
10. **Deviation of Order quantity:** Up to 10% variations in the execution of purchase order of the total o

order value for sanctioned order value is allowed without issue of amendment / revision in the purchase order.

iii) AMRCD

Any disputes or differences between the parties are not settled amicably with conciliation and/or Mediation, then such disputes or differences shall be resolved through Administrative Mechanism for Resolution of CPSEs Disputes (AMRCD). Any disputes or differences relating to interpretation and application of the provisions of commercial contract(s) between Central Public Sector Enterprises (CPSEs)/Port Trusts, inter-se and also between CPSE(s) and Government Department(s) / Organization(s) shall be taken by either party for its resolution through AMRCD.

iv) ARBITRATION :

11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in

the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
