ATC (Additional Terms and Conditions)

1. Uniform:

The deployed manpower will be provided uniform, Safety Shoes by the concerned contract ors and the expenditure towards the same will be reimbursed to them by the corporation on submission of documents / proof of receipt as given hereunder:

- 1. Uniform @ Rs. 1500 per person per year
- 2. Safety Shoes @ Rs. 500 per person per year

2. Retrenchment Benefit

As per the Industrial Disputes Act, 1947 Sec. 25F, in case an employee has completed 240 days then he will be entitled to 15 days retrenchment compensation besides one month's s alary in lieu thereof as if he has worked for one year.

Retrenchment compensation @ minimum wages of 15 days without any deduction and the expenditure towards the same will be reimbursed to them by the corporation on submission of documents / proof of receipt.

3. National Holiday

As per Labour Laws the employers should provide paid day off for the three national holida ys in a year. If the employee works on these days then they will be paid double of their min imum wages on that holiday and the expenditure towards the same will be reimbursed to them by the corporation on submission of documents / proof of receipt.

4. EARNED LEAVE [EL]:

As per Mines Act 1952 a worker is entitled for Earned Leave with wages @ 1 day earned leave per 20 days of service rendered on Surface and 1 day of Earned Leave per 15 days of service rendered in the underground subject to the maximum of 15 days in a calendar year.

Eligibility: In order to earn eligibility for Earned Leave, a worker must have worked not less than 240 days in a calendar year in case he is employed on surface and 180 days in case of employed in the underground.

5. Tools & Tackles

The L1 bidder have to provide tools & tackles of approx. Rs. 20,000/- as per the requiremen t and instruction of Engineer-In-Charge and the expenditure towards the same will be reimb ursed to them by the corporation on submission of documents / proof of receipt.

The tools and tackles provided by the contractor as per the estimated amount of Rs. 20,00 0/- against the tender will be company's asset after completion of the contract.

6. PAYMENT

In case of payment of wages to all labour is not made on or before 7th of succeeding mont h, failing which necessary action will be taken as deemed fit. Also, a penalty @ Rs.200/- per day or higher penalty for default period will be imposed subject to a maximum of 5 per cen t of the contract value. Levy of penalty does not abrogate contractor from his responsibility for disbursement of wages as per the payment wage act, UCIL shall not be liable for any da mage or compensation payable

7. PENALTY: -

Minimum daily manpower requirement: minimum 08 nos. / day

Penalty for non-deployment of less than above mentioned number of persons:

I. For Highly Skilled person: Rs. 300/head/day

II. For skilled person: Rs. 300/head/day

III. For semi-skilled person: Rs. 300/head/day

IV. For unskilled person: Rs. 250/head/day

Party shall submit labour insurance policy (or ESI) before commencement of work. Tools- ta ckles & safety appliances as per NIT shall be brought before start of work. Failing to this ou tstanding payment will not be released.

During execution of the contract, if it is observed that contractor is not able to supply requir ed number of manpower and work is getting hampered, the competent authority shall have the right to get the work done by engaging other capable external Agency/Agencies at the r isk and cost of the Contractor and management may also terminate the Work Order.

Normal working will be six days a week. However, the contractor may be required to deplo y workmen on Sundays, if the need arises. Sometimes it may be required that due to unavoidable reasons the work could not be completed during 'A' shift and in such cases, the contractor may be asked to deploy work men in 'B' and 'C' shift also.

- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्तें</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्तें is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
