Sub: - Repairing of 01 nos. Compressor installed (Make– ATLAS COPCO, Model - AIREND GA 160W) of TMD Mines. (LED Panel replacement, Fitment, and maintenance)

You are invited to offer sealed quotation for the subject work in duplicate based on the term and conditions given below: -

**1. Basis of Evaluation**

Offer submitted by the bidder shall be in single part. Evaluation of L1 (Lowest) bidder shall be done based on their lowest quoted in totality. Bidder should quote their total both in figures as well as in words. In case of any discrepancy in figure and words then written in words will be final. The quoted rates should be inclusive of all taxes.

2. Completion of work: Total work should be completed within 15 days from the date of issuing of work order.
3. The offer must be valid for six months from the date of opening and no contractor shall be allowed to withdraw his/her offer within this period.
4. There will be 03 months defect liability period for the work.
5. Guarantee/Warranty of the repair should be 01 year. If any fault comes within this period, it should be rectified free of cost.
6. The price quoted should be firm and no escalation on any account whatsoever will be entertained/paid by the corporation.
7. Payment would be released by Jamshedpur/Jaduguda – cheque/Payments would be released by RTGS/ e. Payment.
8. PAYMENT TERMS: Only one bill shall be payable against submission of duly certified bill after joint measurement. Bill payment shall be payable only through e-payment. The decision of Engineer-in-charge in this matter shall be final.
9. All the rates quoted by shall be inclusive of cost of all materials, labour, tools, tackles, plant and machinery necessary to complete the work at no extra cost to corporation for any item.
10. In the event of a discrepancy between description in words and figures quoted by a Tenderer the description in words shall prevail.
11. No any carriage/transportation for any material except otherwise stated in schedule of quantities shall be paid by the department for this work. Contractor should quote their rates accordingly.
12. Job is to be carried out at UCIL Turamdih MRS area, transportation and material handling charge will be in contractor scope.
13. Scope of work: As mentioned in Annexure-II. All the material required for repairing will be under contractor's scope.

14. Quotation must be submitted in the enclosed schedule of quantity (original and two copies in Xerox of the same) duly signed along with seal of the agency. Duly filled quotation shall be submitted in the sealed envelope and to be deposited in the office of Manager (Pers.), Turamdih upto 28/02/2025 (11.30 am) and if will be opened on 28/02/2025 i.e. same day at 3.30 pm at Turamdih.
15. All other terms and conditions shall be applicable as per General conditions of UCIL's tender norms.
