PRE-QUALIFICATION CRITERIA (PQC) OF TENDERERS

Only such firms need to tender who can produce satisfactory evidence that they have the necessary experience & financial resources to undertake such work as per criteria mentioned below.

- i) Experience of having successfully completed SIMILAR WORK during last 07 years ending last day of mont h previous to the one in which applications are invited should be either of the following:
- a) One similar completed works costing not less than the amount equal to Rs. $4.03 \; \text{Lack}$ Or
- b) Two similar completed works each costing not less than the amount equal to Rs. 2.52 Lack Or
- c) Three similar completed works each costing not less than the amount equal to Rs. 2.01 Lack

"Similar work" means experience in Making of Rope thread of old broken/ wear out rope thread of Drifter R od R 38-H35-R32 OR Lathe Work of Turning Jobs(related to fabrication/Repairing of Cylinder) of Undergrou nd Machines. The bidder will have to submit copy of the relevant work order / LOI / LOA clearly indicating Work Order Value (in INR) and its completion certificate, from the client, as documentary evidence in supp ort of their experience / credential, failing which offer shall be summarily rejected. The submitted Work Or ders / LOI / LOA and Completion Certificate shall be either English or Hindi only. Credentials other than Eng lish or Hindi language shall not be considered.

- ii) The tenderer's average annual turnover during last 03 years, ending 31st March of the previous financia I year i.e. 2021-22 should be at least Rs.1.51 Lack. Annual Report containing Profit & Loss account and Bal ance sheet along with ITR duly audited by CA/Cost Accountant for last 3 FYs must be submitted.
- ii) Geographical Presence: Proof of having Registered Office and workshop located and registered within the home state of the buyer i.e. Jharkhand where the services needed to be provided. Documentary evidence must be provided in the form of Municipality trade license or other such documents as per the following which satisfies as a proof of having the office establishment.
- i. Trade License issued by the local authority in the name of the Firm OR
- ii. Incorporation Certificate of the firm clearly mentioning office address OR
- iii. Electricity bill for last one year in the name of the Firm OR
- iv. GSTIN registration
- v. Udyam/MSME/NSIC/SSI

IN ADDITION TO ABOVE

- iii) Workshop facility should be located within a range of 50 KM where the service needs to be provided.
- iv) IGST should be registered within the state of JHARKHAND within a range of 100 KM where the service n eeds to be provided &
- v) MSME should be registered within the state of JHARKHAND within a range of 100 KM where the service needs to be provided.

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
