#### **PRE-QUALIFICATION CRITERIA (PQC) OF TENDERERS:**

Only such firms need to tender who can produce satisfactory evidence that they have the necessary experience & financial resources to undertake such work as per criteria mentioned below.

i) Experience of having successfully completed **similar work in any Central / State Govt. Organization / PSU / Public Listed Company** during last 07 years ending last day of month previous to the one in which applications are invited should be either of the following:

a) One similar completed works costing not less than the amount equal to **Rs.1014181.60/-**

Or

b) Two similar completed works each costing not less than the amount equal to **Rs.633863.50/-**

Or

c) Three similar completed works each costing not less than the amount equal to **Rs.507090.80/-**

**“Similar work”** means experience in carrying out electrical jobs (jobs of laying of HT/LT cables ( minimum 250 mtrs of cable length under one Work Order etc.) OR erection of at least 2 Nos. of poles of pole length not less than 9 Mtrs. for over-head power lines / MCC / PDB / HT Panel / Transformer (minimum 500 KVA, 3 Ph.) including laying of HT/LT armoured cables (under one Work Order) or maintenance of over-head power lines of 6.6 KV or more rating.

The bidder will have to submit **valid electrical contractor license issued by the state / central electricity licensing board (mandatorily)** and a copy of the relevant work order / LOI / LOA clearly indicating Work Order Value (in INR) and its completion certificate from the client as documentary evidence in support of their experience / credential failing which offer shall be summarily rejected. **The submitted Work Orders / LOI / LOA and Completion Certificate shall be either English or Hindi only clearly showing contract Value / executed value. Credentials other than English or Hindi language shall not be considered.**

**ii)** Proof of having Registered Office and workshop located and registered within the home state of the buyer i.e. **Jharkhand** where the services needed to be provided. Documentary evidence must be provided in the form of Municipality trade license or other such documents as per the following which satisfies as a proof of having the office establishment.

- i. Trade License issued by the local authority in the name of the Firm OR
- ii. Incorporation Certificate of the firm clearly mentioning office address OR
- iii. Electricity bill for last one year in the name of the Firm OR
- iv. GSTIN registration
- v. Udyam/MSME/NSIC/SSI

**Please note that any type of Rental / Tenancy / Leave and License etc. agreement are not valid proof of having the office establishment within the home state of the buyer i.e. Jharkhand and the bidder submitting such documents shall not be considered.**

**iii)** The minimum average annual financial turnover of the bidder during the last three years, ending on 31<sup>st</sup> March of the previous financial year i.e. 2023-24, shall be at least **Rs.4.00 lakhs**. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

**Poor Response Clause (As per Clause No.36 of STC):**

The eligibility shall be decided strictly based on documents submitted at the time of receipt of tenders. No additional documents shall be allowed to be submitted after receipt of tenders. However, in case of poor response, with a view to increase the competition, admission of additional documents to meet the PQ-Criteria may be allowed subject to the condition that:

#### 9. **Purchase Preference (Centre)**

3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
