If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. 3. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

4. OEM Turn Over Criteria: The minimum average annual financial turnover of the OEM of the offered product during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the OEM is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

5. Bid reserved for Make In India products: : Procurement under this bid is reserved for purchase from Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. However, eligible micro and small enterprises will be allowed to participate. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which the bid is liable to be rejected. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020 . In case Buyer has selected Purchase preference to Micro and Small Enterprises clause in the bid, the same will get precedence over this clause.

6. Procurement under this bid is reserved for purchase from Micro and Small Enterprises having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal. If the bidder wants to avail themselves of the reservation benefit, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible to participate in this bid. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility based on documentary evidence submitted, while evaluating the bid. 7. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

8. - E) The scope of work also includes the following for which no extra payment will be made. Ther efore, contractor may consider this while quoting their rate of other items as mentioned und er bill of quantities for various items of work

The Contractor shall carry out and complete the said work in every respect in accordance wi th the Contract and with the direction of and to the satisfaction of the Corporation. The Corpo ration may in his absolute discretion and from time to time issue further drawings and /or wr itten instructions, details, directions and explanations, which are hereafter collectively referr ed to as UCIL's instructions in regard to: i. The variation or modification of the quantity of works or the addition or o mission or substitution of any work well within the value of the order has to be obe yed and accepted by the bidder.

ii. Any discrepancy in the Drawings or between the Schedule of Quantities a nd/or Drawings and /or Specifications has to be obeyed and accepted by the bidder

iii. The removal from the site of any material brought there on by the Contra ctor and the substitution of any other material thereof.

iv. The removal and/or re-execution of any works executed by the Contractor

v. The dismissal of any person from works employed there upon.

vi. Opening up for inspection of any work covered up.

vii. Amending & making good of any defect of work up to two years from the date of completion of work. So bank guarantee will be force to valid up to perform ance guarantee period and claim period.

Electrical scope: Contractor has to follows as per electricity act 2003 & CEA R regulations 2010 while constructing the building. Contract agency has to stri ctly adhere to schedule of quantities.

3. Completion Period:

7. Variation and schedule of Quantities:

The quantities may vary from those indicated in the tender documents due to the actual condition of the site or due to ot her reasons. The contractor shall carry out all the work up to a total variatio n of 10% on the contract price and up to any extend of individual items of schedule of quantities. All tendered rate shall remain firm within this limit and extra items may be included.

8. Extension:

Completion period of contract is **12(Twelve) months** from the date of commencement. The bidde r should give the details of his bank account in the prescribed E-banking format to facilitate payment through e- banking in case of award of wor k on him. As per provisions contained in statutory Labour /Industrial Law s, copy of wage sheet, wage slip, PF and ESIC latest challans should be enclosed with the monthly bills. Payment will be released after satisfact ory completion of the work or event (in case of continuous supply of ser vices) in all respect and certification by the Engineer In charge, UCIL wi thin 30 days of submission of tax invoices(s) in original + duplicate 2 (t wo) copies as prescribed under rule 1 of invoices rules subject to the pr ovision of adjustment of dues and statutory deductions as applicable. C ontractor shall issue tax invoice (s) after the provision of service within 30 days from the date of certification of work or event, & also mention work order no., date as well as name of work and actual date of comme ncement of work or event, showing the description, value, tax charges t hereon and such other particulars as prescribed as per GST Act, 2017 in voice rule in their every invoice(s).

a The bidder should get the labour license for supplying of manpow er as per our requirement mentioned in NIT, before commencem ent of work or within one month after commencement of work.

bAge limit for unskilled and semiskilled manpower must not be more than 55 years.

11. Indemnity:

Contractor will fully indemnify the corporation against all responsibility, any costs or expenses (including legal costs on an indemnity basis) and Claims of contractor's workmen in respect of personal injury or death or loss of, or damage to or interference with, any other property (whether real or personal), third party or to corporations' personnel and propertie s. Contractor shall abide by all the necessary provisions of vario us other Labour Laws/Acts viz. ESI/Bonus, Workmen's Compens ation, EPF and any other laws and rules applicable, in this regar d. If on account of non- compliance with the provisions of any la ws, Corporation is called upon to make any payment to or in res pect of his employees, the service provider shall fully reimburs e to Corporation for all such payment and Corporation shall be f ree to make deductions on this account from the amount of Per formance Security Deposit and retention money.

12. Insurance:

The contractor shall obtain necessary insurance coverage till the arrang ement of ESI for each deployed worker as per statutory requirement. Th e copy of insurance to be furnished to UCIL.

13. Variation in schedule of quantities (or) Total amount:

Any Schedule of quantities (or) Total amount may vary up to any extent subject to gross variation of maximum \pm 10 % (ten percent) of contract value. Contractor should agree and liable to execute above variation at the same rate, terms and conditions stipulated in the contract.

14. Labour Licens:

If applicable, necessary Labour License shall be obtained by the contractor for the workman engaged at site at his own cost whi ch shall be reimbursable on submission of documentary evidenc e. The Labour License shall be required to be obtained for the w hole period of the contract and shall be furnished to the corpor ation before commencement of the work.
