2. Only such firms need to tender who can produce satisfactory evidence that they have the necessary experience & financial resources to undertake such work as per criteria mentioned below.

i) Experience of having successfully completed SIMILAR WORK during last 07 years ending last day of month previous to the one in which applications are invited should be either of the following:

a) One similar completed works costing not less than the amount equal to Rs.11.13 Lacks.

Or

b) Two similar completed works each costing not less than the amount equal to Rs.6.96 Lacks.

Or

c) Three similar completed works each costing not less than the amount equal to Rs.5.56 Lacks.

“Similar work” means experience in Painting work related with Machine/ civil Structure/ Mechanical Structure. The bidder will have to submit copy of the relevant work order / LOI / LOA clearly indicating Work Order Value (in INR) and its completion certificate, from the client, as documentary evidence in support of their experience / credential, failing which offer shall be summarily rejected. The submitted Work Orders / LOI / LOA and Completion Certificate shall be either English or Hindi only. Credentials other than English or Hindi language shall not be considered.

ii) The tenderer's average annual turnover during last 03 years, ending 31st March of the previous financial year should be at least Rs 4.17 Lacks. Annual Report containing Profit & Loss account and Balance sheet along with ITR duly audited by CA/Cost Accountant for last 3 FYs must be submitted.

ii) Geographical Presence: MSME should be registered within the State of JHARKHAND.

iii) Proof of having Registered Office and workshop located and registered within the home state of the buyer i.e. Jharkhand where the services needed to be provided. Documentary

evidence must be provided in the form of such documents as per the following which satisfies as a proof of having the office establishment.

- i. Property ownership deed in the name of the Firm OR
- ii. Incorporation Certificate of the firm clearly mentioning office address OR
- iii. Electricity bill for last one year in the name of the Firm
- iv. GSTIN registration in the name of the Firm.

Scope of Work

1. Work will be carried out at Turamdih work shop, inside the UCIL Premises.
2. Purchase, Transportation/ Handling of all the material required to complete the painting Job, (to and fro) will be in Contractors Scope, and no extra charges will be paid for the same.
3. Total area to be painted-5510 sqm.
4. Work to be carried out
 - a. Supply and painting with Epoxy/ Automotive Paint by spray painting method on underground diesel equipment with three coat with suitable epoxy primer including scaffolding and all height upto 10 mtr, wire brushing using angle grinder, removing dust, rust, spillage etc. of structure and making suitable as per instruction of Engineer In-Charge. For White Paint- Francoise White, for yellow Paint- Golden Yellow, For Dawn Paint- Dawn Glow & Black Paint. All Paints, Painting materials and any other accessories to complete the job shall be under contractor's scope.
 - b. Supply and painting of Red Oxide Primer by spray painting method on underground diesel equipment with two coat with suitable epoxy primer including scaffolding and all height upto 10 mtr, wire brushing using angle grinder, removing dust, rust, spillage etc. of structure and making suitable as per instruction of Engineer In-Charge. All machines should be thoroughly washed. All rusted surface should be cleaned and polished before painting. All Paints, Painting materials and any other accessories to complete the job shall be under contractor's scope.
5. Frequent visit will be done by Engineer in-charge or his representative for inspection of quality of the work.
6. The Contractor will have to get written confirmation of the colour (Specimen) of the Paint, Red-oxide and Thinner before the start of the work by the Engineer In-Charge.
7. As all the machine is in production use, hence a certain limited time/day will be allowed to the contractor to complete the painting job. The contractor has to deploy enough numbers of persons to complete the said job within time limit.

8. The work will be done in “Part by Part” so as not to hamper the production Job, as per instruction of Engineer in-charge or his representative.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is governed by the [General Terms and Conditions/सामान्य नियम और शर्तें](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्तें is contradicted by the conditions stipulated in
