- 1. <u>Scope of work:</u> The scope of work includes dismantling of old Precoat Filter, repair work for strengthening of Precoat vat, agitator and Erection & Commissioning of new bare Precoat Filter. All dismantled ma terial shall be removed from operation premises as scrap and disposal of same in UCIL's scrap yard as directed.
- 2. <u>Approximate Quantity:</u> As per schedule of item mention in annexur e.
- **3.** <u>Completion Time:</u> Validity of completion period is (12) twelve month s from the date of commencement of work. Work has to be complete wi thin the time period as per instruction and availability of site.

- ii. The Tenderer resile from his offer during the validity period.
- iii. The tender is revoked during its validity period by the Tenderer or any other breach of the bid.
- iv. The Tenderer increases the prices unilaterally after the opening of Part I (techno-commercial) and during the validity period of the tender.
- v. Subsequent to acceptance of the Letter of Award of Contract by th e successful Tenderer, the Tenderer refuses to enter into Contract Agreement within the specified time or its authorized extensions.
- vi. The successful Tenderer fails to submit the Performance Guarante e (Security Deposit) within theperiod specified, if applicable.
- vii. The Tenderer does not accept the correction of the Bid Price, by s ubmission of updated bid.

The EMD/ Bid Security of the successful Tenderer to whom the contract is awarded will be returned oradjusted into Security Deposit (SD) after the said Tenderer provides the Contract PerformanceGuarantee/ Security Deposit (SD) and signs the Contract Agreement.

If the successful Tenderer fails to submit Contract Performance Guarant ee/ Security Deposit (SD) as specified within 30 (thirty) days after the da te of issue of Letter of Award of Contract, or fails to sign the contract agreement then the EMD/ Bid Security amount will be forfeited by the C orporation, without any notice or proof of damages etc.

3. Validity of Tender: Bids shall be kept valid for period specified in GeM Portal from the final Due date of submission of bid'. A Bid valid for a sho rter period may be rejected by UCIL as 'nonresponsive'. The Tenderers s hall not be allowed to increase, amend or withdraw his tender within this period and if he does so the earnest money deposit and security deposit may be forfeited.

If required, the Corporation may request the Tenderer to extend the "bid validity period". The request and responses thereto shall be made in writing or through GeM portal, if a tenderer accepts to extend the period of validity of bid. The tenderer accepting such request shall not modify their bid on their own. A Tenderer may refuse the request to extend the bid validity period without forfeiture of his EMD.

- **4. Deviation:** ZERO DEVIATION: Deviation to terms and conditions of "Bid ding Documents" may lead to rejection of bid. UCIL will accept bids base d on terms & conditions of "Bidding Documents" only. Bidder may note UCIL will determine the substantial responsiveness of each bid to the Bi dding Documents. For purpose of this, a substantially responsive bid is one which conforms to all terms and conditions of the Bidding Documen ts without deviations or reservations. UCIL's determination of a bid's responsiveness is based on the content of the bid itself without recourse to extrinsic evidence. UCIL reserves the right to raise technical and/or commercial query(s), if required, may be raised on the bidder(s). The response(s) to the same shall be in writing, and no change in the price(s) or substance of the bids shall be sought, offered or permitted. The substance of the bid includes but not limited to prices.
- **5. Award of Contract:** The Corporation will award the Contract to the succ essful Tenderer, whose bid/updated bid has been determined to be subs tantially responsive and to be the lowest evaluated bid, provided that the Tenderer is determined to be qualified to perform the Contract satisfactorily.
- **6. Privilege Clause:** The Corporation reserves the right to accept or reject any Tender, and to cancel the Tender process and reject all Tenders, at any time prior to the award of Contract, without thereby incurring any li ability to the affected Tenderer or Tenderers or any obligation to inform the affected Tenderer or Tenderers of the grounds for the Corporation's action.
- 7. SECURITY DEPOSIT (SD): Total amount of Security deposit shall be lim

ited to 10 % of the awarded value of work. Fifty percent of this amount s hall have to be deposited as initial security deposit at the time of execut ion of agreement including the amount deposited as Earnest Money.

- a. Acceptable mode of payment of Initial Security Deposit/ Earnest Mone y:
 - i. For deposit upto Rs. 5,000/- : Demand Draft payable at SBI, Jadu guda/ Hartopa.
 - ii. For deposit beyond Rs. 5,000/- and up to Rs. 1.00 Lakh.: DAC/TD R/FDR etc. from anySchedule Banks duly pledged in favour of U CIL. But in case of Earnest Money of amount more than Rs. 50,0 00/-, the Tenderer should submit Bank Guarantee issued by Nati onalized bank as mentioned in Para 9(a) (iii).
 - iii. For deposit beyond Rs. 1.00 Lakhs: Bank Guarantee issued by S cheduled bank of jointly, severally bound with the Contractor to the purchaser for the amount same above. The terms ofthe said guarantee shall be such as shall be approved by the purchaser and the obtaining ofsuch guarantee and the cost of guarantee t o be so entered shall be at the expenses, in allrespects, of the C ontractor. The said guarantee shall be valid till the expiry of the defect liabilityperiod and issue of the final certificate by the Eng ineer, and with a claim period of Six months beyondits required validity.
 - iv. In addition to the above, if contractor failed to submit the securi ty deposit, S.D. value ofthe work will be deducted from the 1st / subsequent Running Account bills by way ofpercentage deducti ons. Such percentage deduction shall be @ 10 % of the running accountbills till the full amount of security deposit is realized/ re tained by the Corporation.
- b. All compensation or other sums of money payable by the Contractor under the terms of this contact orany other contact or any other account whatsoever may be deducted from or paid by sale of a sufficientp art of his security deposit or from the interest arising there from or from any sums which may be due orbecome due to the Contractor by the Corporation or any account whatsoever and in the event of hissecurity deposit be reduced by reason of any such deduction or sale as a foresaid, the Contractor shallwithin fourteen days of receipt of notice of demand from the Engineer-in-charge make good the deficit.
- c. REFUND OF SECURITY DEPOSIT: Security Deposit (SD) shall be refunded to the Contractor on the Engineer-in-charge certifying in writin

g that the work has been completed as per condition <u>Penalty (Liqui dated Damage clauses hereof etc against submission of a Per formance Bank Guarantee (PBG) for 10 % of the work order value Or You will be given the option to convert SD BG in to PBG and on expiry of the Defects liability period (referred to in condition Penalty (Liquidated Damage clauses hereof) or after payment of the Final billpayable whichever is later, the Engineer-in-charge shall on request from the Contractor refund to himthe security deposit provided the Engineer-in-charge is satisfied that there is no demand outstanding against the Contractor.</u>

- **8. FORFEITURE OF SD:** The SD shall stand forfeited in favour of UCIL, with out any further notice to the contractor in the following circumstances:
 - · In case of any failure whatsoever on the part of the contractor at an y time during performance of his part of the contract including the extended periods of contract, where notice is given and time for rectification allowed.
 - · If the contractor indulges at any time in any subletting/ sub-contract ing of any portion of thework without approval of UCIL.

9. Contract Agreement:

Contract Agreement should be executed in prescribed format on a non-judicial stamped paper within 30 (thirty) days from the date of issue of w ork order / L.O.I. However, no payment will be made without execution of contract agreement.

Within 30 days of issue of LOI, the successful Tenderer shall sign and da te the contract and return it to the Corporation. Till the contract is signed , the LOI issued to the successful Tenderer shall remain bindingamongst the two parties.

In the event of failure on the part of the successful Tenderer to sign the contract within the period specified above or any other time period specified by Corporation, UCIL reserves the right to terminate the LOI issuedt o the successful Tenderer and invokes the Bid Security or the Performan ce Security if submitted by thesuccessful Tenderer/ action as per declar ation for Bid Security.

10. Payment Terms:1. Payment will be released after satisfactory **comp letion of the work** or event (in case of continuous supply of services) in all respect and certification by the Engineer In charge, UCIL within 30

days of <u>submission of tax invoices(s)</u> in <u>original + duplicate 2 (two) copies</u> as prescribed under rule 1 of invoices rules. Contractor shall issued t ax invoice (s) after the provision of service within 30 days from the date of certification of work or event, & also mention work order no., date as well as name of work and actual date of commencement of work or event, showing the description, value, tax charges thereon and such other p articulars as prescribed as per GST Act, 2017 invoice rule in their every invoice(s).

3 (Three) R.A. bills and 1 (One) final bill will be paid against this work af ter submission of bill in 4 (four) copies. Payment will be released after s atisfactory completion of the work in all respect and certification by the Engineer In charge, UCIL within 30 days of submission of clear bill(s) in 4 (Four) copies in tenderer's letter head. Contractor shall also mention work order no., date as well as name of work and actual date of comme ncement of work in their every bill(s). Final bill will be released only after submission of Labour Report / Annual Return (in prescribed format) and work completion letter in duplicate by the contractor.

Hundred percent (100%) payment including GST will be paid completely or on pro-rata basis in case of continuous supply of services (as per RA Bills) after completion of work/ supply as certified by the Corporation, against submission of a Performance Bank Guarantee (PBG) for 10 % (As per DoE OM 12.11.2020) of the work order value. PBG will be return on expiry of the Defect sliability period (referred to in condition Penalty (Liquidated Damage clauses hereof) and after completion of all obligations under the contract.

11. Tax & Duties: The Contractor shall:

- a. Pay and indemnify the Corporation against all taxes, duties, goods and services tax and duties, charges, taxes payable in connection with the carrying out of Work under Contract; and
- b. Provide all security required under any statutory requirement as se curity for the payment of any duties, charges, and taxes.
- 12. INCOME TAX & STATUTORY LEVIES: Income Tax at the prevailing ra te as applicable from time-to-time shall be deducted from CONTRACTOR 's bills as per Income Tax and quoted rates shall be deemed to include this. As regards the Income Tax, surcharge on Income Tax or any other C orporate Tax or Statutory levy payable by the Tenderer for reason of the Contract awarded, then Corporation shall not bear any tax liability what soever, irrespective of the mode of construction of contract. The Tender

er both Indian and/or foreign shall be liable and responsible for payment of such tax, if attracted under the provision of Law of Land.

13. Insurance: The contractor shall ensure & maintain insurance against h is liability for accident or injury to workmen or machineries used for the work and shall submit 2 (two) copies of the policy & receipt (s) of premi ums paid or satisfactory evidence of insurance coverage at their own co st valid for whole contract period at a time for all the persons to be enga ged to the Engineer-In -charge, UCIL before the commencement of work. Contractor shall also submit the proof of renewal of the same policy at least 2 (two) days before the expiry date of the previous policy to the Engineer-In-charge, UCIL. The contractor will not be allowed to carry out any activity without necessary insurance coverage (mentioning working he ight depend upon the job requirements and as per insurance rules) of the eir persons. Insurance policy shall also indemnify UCIL against any claim raised by the injured / affected workmen or his family.

14. Penalty (Liquidated Damage):

- a. Liquidated Damages (LD) shall be levied where reasons are attributab le to supplier / contractors fordelays in execution of purchase order/ c ontract. LD shall be levied @0.5% per week or part thereof onthe value of unfinished supply/work order for each week of delay subject to a maximum of 5% of thetotal value of contract (excluding Taxes and Duties). LD is liable to GST at applicable rate.
- b. For the portion of delay which is attributable to UCIL / force majeure o r to the supplier / contractor, thecase shall be dealt with as follows :
 - I. Delay attributable to UCIL / Force majeure:

- c. The payment of liquidated damages shall not relieve the Contractor fr om its obligation tocomplete the Works.
- **15. Variation in Price:** Unless the <u>Clause Price Adjustment</u> provides ot herwise the rates and prices quoted by the Tenderer shall be fixed for the duration of the Contract and shall not be subject to adjustment or any account.
 - 15.1. **Variation in Quantity of items:-** The quantity mentioned under the "sche dule of item (s) and quantities" of this tender is tentative. The actual quantity may vary from that indicated in the tender document due to actual conditions of the site or due to other reasons. The contractor shall carry out all additiona I work up to the total variation of + 10% of the awarded value. The other terms & conditions and rate (s) shall remain firm within this limit.
- **16. Termination for Insolvency:**The Corporation may at any time termin ate the Contract by giving written notice of four weeks to the Contractor, without any compensation to the Contractor, if the Contractor becomes bankrupt or otherwise insolvent.

17. Defaults, Breaches, Termination, and closure of Contract:

- 1) Termination due to Breach, Default, and Insolvency
- a) Defaults and Breach of Contract
 - In case the contractor undergoes insolvency or receivership; neglects or defaults, or expresses inability or disinclination to honour his oblig

ations relating to the performance of the contract or ethical standard s or any other obligation that substantively affects the Procuring Entit y's rights and benefits under the contract, it shall be treated as a bre ach of Contract. Such defaults could include inter-alia:

- i. Default in Performance and Obligations: if the contractor fails to delive r any or all of the Services or fails to perform any other contractual o bligations (including Code of Integrity or obligation to maintain eligibil ity and Qualifications based on which contract was awarded) within t he period stipulated in the contract or within any extension thereof gr anted by the Procuring Entity.
- ii. Insolvency: If the contractor being an individual or if a firm, any partn er thereof, shall at any time, be adjudged insolvent or shall have a re ceiving order or order for the administration of his estate made again st him or shall take any proceeding for composition under any Insolvency Act for the time being in force or make any conveyance or assignment of his effects or enter into any assignment or composition with his creditors or suspend payment or if the firm be dissolved under the Partnership Act, or
- iii. Liquidation: if the contractor is a company being wound up voluntaril y, or by order of a Court or a Receiver, Liquidator or Manager on behalf of the Debenture-holders is appointed, or circumstances shall have arisen which entitle the Court or Debenture- holders to appoint a Receiver, Liquidator or Manager.

b) Notice for Default:

As soon as a breach of contract is noticed, a show-cause 'Notice of D efault' shall be issued to the contractor, giving two weeks' notice, res erving the right to invoke contractual remedies. After such a show-ca use notice, all payments to the contractor would be temporarily withh eld to safeguard needed recoveries that may become due on invoking contractual remedies.

c) Terminations for Default

- i. Notice for Termination for Default: In the event of unsatisfactory resolution of 'Notice of Default' within two weeks of its issue as per sub-clause above, the Procuring Entity, if so decided, shall bywritten Notice of Termination for Default sent to the contractor, terminate the contract in whole or inpart, without compensation to the contractor.
 - ii. Such termination shall not prejudice or affect the rights and remedie s, including under sub-clausebelow, which have accrued and/ or shall accrue to the Procuring Entity after that.
 - iii. Unless otherwise instructed by the Procuring Entity, the contractor s hall continue to perform the contract to the extent not terminated.

- iv. All Defect Liability obligations, if any, shall continue to survive despite the termination.
- d) Contractual Remedies for Breaches/ Defaults or Termination for Default

If there is an unsatisfactory resolution within this period, the Procuring Entity shall take one; or more ofthe following contractual remedies.

- i. Temporary withhold payments due to the contractor till recoveries du e to invocation of othercontractual remedies are complete.
- ii. Call back any loaned property or advances of payment, if any, with a levy of interest at the prevailing rate (MIBID - Mumbai Interbank Bid Rate).
- iii. Recover liquidated damages and invoke denial clause for delays.
- iv. Encash and/ or Forfeit performance or other contractual securities.
- v. Prefer claims against insurances, if any.
- vi. Terminate Contract for default, fully or partially including its right for Risk-and-Cost Procurementas per following sub-clause.
- vii. Risk and Cost Procurement: In addition to termination for default, t he Procuring Entity shall be entitled, and it shall be lawful on his par t, to procure Services similar to those terminated, with such terms a nd conditions and in such manner as it deems fit at the "Risk and Co st" of the contractor. Such Risk and Cost Procurement must be contracted within six months from the breach of Contract. The contr actor shall be liable for any loss which the Procuring Entity may sust ain on that account provided the procurement, or, if there is an agre ement to procure, such agreement is made. The contractor shall not be entitled to any gain on such procurement, and the manner and method of such procurement shall be in the entire discretion of the Procuring Entity. It shall not be necessary for the Procuring Entity to notify the contractor of such procurement. It shall, however, be at t he discretion of the Procuring Entity to collect or not the security de posit from the firm/ firms on whom the contract is placed at the risk and cost of the defaulted firm.
- viii. Note: Regarding the Services that are not readily available in the market and where procurement difficulties are experienced, the peri od for making risk procurement shall be nine months instead of six months provided above.
- ix. Initiate proceedings in a court of law for the transgression of a law, tort, and loss, not addressable by the above means.

e) Limitation of Liability

Except in cases of criminal negligence or willful misconduct, the agg regate liability of the contractor tothe Procuring Entity, whether und er the contract, in tort or otherwise, shall not exceed the totalContract Price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment, or to any obligation of the contractor to indemnify the Procuring Entity concerning IPRinfringe ment.

- 2) Termination for Default/ Convenience of Procuring Entity and Frustrati on
 - a) Notice for Determination of Contract
 - i. The Procuring Entity reserves the right to terminate the contract, in whole or in part for its (the Procuring Entity's) convenience or frustration of Contract as per sub-clause below, by serving written 'Notice for Determination of Contract' on the contract tor at any time during the currency of the contract. The notice shall specify that the termination is for the convenience of the Procuring Entity or the frustration of the contract. The notice shall also indicate inter-alia, the extent to which the contractor's performance under the contract is terminated, and the date with effect from which such termination shall become effective.
 - ii. Such termination shall not prejudice or affect the rights and re medies accrued and/ or shall accrueafter that to the Parties.
 - iii. Unless otherwise instructed by the Procuring Entity, the contractor shall continue to perform the contract to the extent not terminated.
 - iv. All Defect Liability obligations, if any, shall continue to survive despite the termination.
 - v. The Services and incidental goods/ works that can be delivered or performed within thirty daysafter the contractor's receipt of the notice of termination shall be accepted by the Procuring E ntityas per the contract terms. For the remaining Services and incidental goods/ works, the ProcuringEntity may decide:
 - 1. To get any portion of the balance completed and delivered at the contract terms, conditions, and prices; and/ or
 - 2. To cancel the remaining portion of the Services and incidenta I goods/ works and compensate the contractor by paying an agreed amount for the cost incurred by the contractor, if any

,towards the remaining portion of the Services and incidental goods/ works.

a) Frustration of Contract

- i. Notice of Frustration Event: Upon a supervening cause occurrin g after the effective date of the contract, including a change in law, beyond the control of either party whether as a result of the Force Majeure clause or within the scope of section 56 of the Indian Contract Act, 1872, that makes it impossible to perform the contract within a reasonable timeframe, the affected party shall give a 'Notice of Frustration Event' to the other party giving justification. The parties shall use reasonable efforts to agree to amend the contract, as may be necessary to complet e its performance. However, if the parties cannot reach a mutual agreement within 60 days of the initial notice, the Procuring Entity shall issue a 'Notice for Determining the contract' and terminate the contract due to its frustration as in the sub-clause above.
- ii. However, the following shall not be considered as such a super vening cause
- iii. Lack of commercial feasibility or viability or profitability or availability of funds
- iv. If caused by either party's breach of its obligations under this Contract or failure to act in good faithor use commercially reas onable due diligence to prevent such an event.

3) Closure of Contract

The contract shall stand closed upon

- i. Successful performance of all obligations by both parties, including completion of DefectLiability obligations and final payment.
- ii. Termination and settlements after that, if any, as per Terminatio n due to Breach, Default, and Insolvency or Termination for Defa ult/ Convenience of Procuring Entity and Frustration.
- **18. Statutory Variation Clause:**Unless otherwise stated in the contract, statutory increase in applicable GST rate only during the original deliver y period shall be to Procuring Entity's account. Any increase in the rates of GST beyond the original completion date during the extended deliver y period shall be borne by the contractor.

The benefit of any reduction in GST rate must be passed on to the Procuring Entity during the original and extended delivery period. However, G

ST rate amendments shall be considered for quoted HSN code only, against documentary evidence, provided such an increase of GST rates take s place after the last date of bidsubmission.

19. Time for Delivery of services and Extensions Thereof: The time a nd uninterrupted delivery of Services shall be deemed to be the essence of the contract. Subject to any requirement in the contract as to the completion of any portions or portions of the Services before comple tion of the whole; the contractor shall fully and finally complete the whol e of the services comprised in the contract as per the Delivery and Com pletion Schedule stipulated in Format 1.1: Description of Services. If at a ny time during the currency of the contract, the contractor encounters c onditions hindering the timely performance of services, the contractor s hall promptly inform the Procuring Entity in writing about the same and i ts likely duration. He must make a request to the Procuring Entity for an extension of the delivery schedule. On receiving the contractor's comm unication, the Procuring Entity shall examine the situation and, at its dis cretion, may agree to extend the completion schedule, with or without li guidated damages and with and without denial clause by issuing an ame ndment to the contract in terms of the following clauses.

19.1 Extension Due to Modification

The Contract Manager might grant a reasonable extension of the completion date if any modifications ordered materially increase t he time for delivery of the services. The contractor shall be respon sible for requesting such extension of the date as soon as the cau se thereof shall arise and in any case not less than one month before the expiry of the date fixed for completion of the services.

19.2 Extension for Delay Not Due to Contractor

If in the opinion of the contractor, the progress of Services has any time been delayed due to following reasons, then within 15 days of such happening causing delay, he shall give notice thereof in writing to the Contract Manager, but shall nevertheless do due diligence to bring down or make good the delays and to proceed with the services:

- a) any act or neglect of other contractor employed by the Procurin g Entity or in executing the work/service not forming part of the contract but on which Contractor's performance necessarilydep ends or
- b) proceeding taken or threatened by or dispute with external thir d parties arising otherwise thanfrom the contractor's own default etc. or

- c) any act or neglect of Procuring Entity's employees or
- d) delay authorized by the Contract Manager pending arbitration or
- e) The contractor not having received in due time necessary instructions from the Procuring Entity for which he shall have especially applied in writing to the Contract Manager or his authorizedre presentative.
- f) hand over possession of the site or the necessary facilities/ docu ments/ data or instructions bythe Procuring Entity to the contractor or
- g) give the necessary notice to commence the services, or
- h) Any other delay caused by the Procuring Entity due to any other cause whatsoever.
- i) The contractor may also indicate the period for which the Servic es are likely to be delayed and ask for a necessary extension of time. On receipt of such request from the contractor, the Contra ct Manager shall consider the same and grant such extension of time as in his opinion is reasonable regarding the nature and pe riod of delay and the type and quantum of work affected thereb y. No other compensation shall be payable for works so carried f orward to the extended period. The same rates, terms, and con ditions as the original Contract shall apply during theextended p eriod.
- 19.3 Extension of Time for Delay Due to Contractor If the contractor f ails to deliver the Services within the fixed/ extended period for re asons other than those stipulated in contract, the Procuring Entity may, if satisfied that the service delivery can still be completed wi thin a reasonable time, extend the period further.

On such extension, the Procuring Entity shall be entitled without p rejudice to any other right andremedy available on that behalf to r ecover from the contractor as agreed damages and not by way of penalty Liquidated Damages as per contract clauses.

Provided further, that if the Procuring Entity is not satisfied that the service can be completed by the contractor or in the event of fail ure on the part of the contractor to complete the service within the eextension of time allowed further as aforesaid, the Procuring Entity shall be entitled without prejudice to any other right or remedy available in that behalf, treat the delay as a breach of contract and availany or all the remedies thereunder, whether or not actual damage is caused by such default.

Inordinate Delays: Delays due to the contractor of more than one-fourth (25%) of the total completionperiod shall be treated as inord inate delays. Such inordinate delays shall be noted as poorperfor mance and be held against the contractor in future tenders. A show-cause notice shall be issued to the contractor before declaring it a poor performance. Such delays may be considered as a breachof the contract at the option of the Procuring Entity.

20. Suspension of Services

20.1 Suspension Ordered by Contract Manager

The contractor shall, on the order of the Contract Manager, suspe nd the progress of the Services or any part thereof for such time or times and in such manner as the Contract Manager may consider necessary, and shall during such suspension, adequately protect and secure the site and assets so far as is necessary in the opinion of the Contract Manager. If such suspension is -Provided for in the contract, or Necessary for the proper execution of the Services or because of extraneous conditions or by some default on the part of the contractor and or Necessary for the safety of the Services or any part thereof

20.2 Extension of Time and Compensation

The contractor shall not be entitled to the extra costs, if any, incur red by him during the period of suspension of the service, but in the event of any suspension ordered by the Contract Manager for reasons other than aforementioned and when each such period of suspension exceeds 14 days, the Contract Manager shall extend the time of service for completion of the Services as he may conside rproper, having regard to the period or periods of such suspensions and such compensations as the Contract Manager may consider reasonable in respect of expenses incurred by the contractor during the periods of such suspension.

20.3 Suspension Lasting More Than 3 Months

If the Contract Manager suspends the Services or any part thereof for more than three months at a time, the contractor may serve a written notice on the Contract Manager requesting permission top roceed with the suspended part(s) of service. If such permission is not granted within 15 days fromthe receipt thereof, the contractor by further written notice may, treat the suspended part(s) of thes ervice as deleted from the Contract. If the whole of the services h as been suspended, he may treat itas a breach of the contract by the Procuring Entity and avail any or all remedies provided in this regardin the contract.

20.4 Force Majeure

a) On the occurrence of any unforeseen event, beyond the cont rol of either Party, directly interfering with the delivery of Services arising during the currency of the contract, such as war, hostilities, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts, or acts of God, the affected Party shall, within a week from the commencement thereof, notify the same in writing to the other Party with reasonable evidence thereof. Unless otherwise directed by the Procuring Entity in writing, the contractor shall continue to perform its obligations under the contract as far as reasonably practicab le and shall seek all reasonable alternative means for perfor mance not prevented by the Force Majeure event.

If the force majeure condition(s) mentioned above be in forc e for 90 days or more at any time, either party shall have the option to terminate the contract on expiry of 90 days of com mencement of such force majeure by giving 14 days' notice t o the other party in writing. In case of such termination, no d amages shall be claimed by either party against the other, s ave and except thosewhich had occurred under any other clause of this Contract before such termination.

- b) Notwithstanding the remedial provisions contained in Damag es and Deductions Thereof and Termination due to Breach, D efault, and Insolvency, none of the Party shall seek any such remedies or damages for the delay and/ or failure of the oth er Party in fulfilling its obligations underthe contract if it is the result of an event of Force Majeure.
- 21. Defects Liability Period: The defect liability period / guarantee perio d for this job shall be 12 months from the certified date of handing over of job. The contractor shall rectify the defects, if any, detected / reporte d during the guarantee period under this tender from the certified date of completion of work. The contractor shall be responsible to make good and remedy at his own expense within such period, as may be stipulate d by the Engineer-In charge before the expiry of the guarantee period.
- **22. Permits, Approvals and Licenses:** Whenever the delivery of Service s and incidental Goods/ Works requires the contractor to obtain permits, approvals, and licenses from local public authorities, it shall be the contr

actor's sole responsibility to obtain these and keep these current and valid. Such requirements may include but not be restricted to licences or environmental clearance if required. If requested by the contractor, the Procuring Entity shall make its best effort to assist the contractor in complying with such requirements in atimely and expeditious manner, without any dilution of the Contractor's responsibility in this regard.

23. Governing Laws and Jurisdiction

23.1 Governing Laws and Jurisdiction

This Contract, its meaning and interpretation, and the relation bet ween the Parties shall be governed by the Laws of India for the ti me being in force.

Irrespective of the place of delivery, or the place of performance or the place of payments under the contract, the contract shall be deemed to have been made at the place from which the Letter of A ward (LoA, or the contract Agreement, in the absence of LoA) has been issued. The courts of such a placeshall alone have jurisdiction to decide any dispute arising out or in respect of the contract.

23.2 Changes in Laws and Regulations

Unless otherwise stipulated in the contract, if after the last deadlin e for the bid submission (Techno commercial), any law, regulation , ordinance, order or bye-law having the force of law is enacted, pr omulgated, abrogated, or changed in India (which shall be deeme d to include any change in interpretation or application by the competent authorities) that subsequently affects the Delivery Date and/ or the contract Price, then such Delivery Date and/ or Contract Price shall be correspondingly increased or decreased, to the extent that the contractor has thereby been affected in the performance of any of its obligations under the contract. Notwithstanding the foregoing, such additional or reduced cost shall not be separately paid or credited if the same has already been accounted for in the price adjustment provisions where applicable.

24. Price Escalation and Tax & Duties: The escalation will be paid up to the scheduled completion date including duly approved Time extension, if any. No escalation will be attracted for the period beyond duly approved time extension.

Adjustment for revision of minimum wages during the order exe

In case of revision in the minimum wages as notified by the Regional La bour Commissioner /UCIL, adjustment amount to the contractor shall be payable as per the following formula:
