3. **Payment**

It is to be noted that bidders shall take an additional coverage of insurance policy for underground workers under Employees Compensation Act, 1923 for exgratia payment payable to the dependent of injured/deceased worker, which shall be reimbursed when applicable and on claims by the bidder, arising due to unfortunate accidents in the mine, whose ceiling value being Rs. 32067.70 for surface Skilled workers (7 nos.), These shall be reimbursed on producing documentary evidence.

2. It is also to be noted that in addition to the normal working days payment, Wages for National Holidays (3 days) shall be paid to the workers whose ceiling value being Rs. 19529.23 for Surface Skilled workers (7 nos.). These shall be reimbursed on producing documentary evidence.

12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is governed by the [General Terms and Conditions/सामान्य नियम और शर्तें](#), conditions stipulated in Bid and [Service Level Agreement](#) specific to this Service as provided in the Marketplace.
