1. Average Annual financial turnover during the last 3(Three) consecutive financial years, ending 31.03.2024 shall be at least 30% (Rs-12.41 Lacs) of the estimated cost supported by the audited annual accounts of each year.
2. Bidder shall have successfully executed similar work during last 7(seven) years ending on 31.03.2024 as per any one of following:
  - a) Three (3) similar completed work each costing not less than the amount equal to 40% (Rs-16.54 Lacs) of the estimated cost or
  - b) Two (2) similar completed works each costing not less than the amount equal to 50% (Rs- 20.68 Lacs) of the estimated cost or

4. **GEOGRAPHIC PRESENCE:** Office registration certificate: Registered Office or at least one of the registered Branch Office of the Bidder shall be located and registered within the geographical limits i.e. Jharkhand State. Valid Documentary evidence must be provided in the form of Municipality trade license or other such documents as per the following which satisfies as a proof of having the office establishment.

- i) Trade License issued by the local authority in the name of the Firm or
- ii) Landline phone number in the name of the Firm or
