**3. *Bidders must attach Work done certificate mentioned executed amount and date of completion.***

4. **Similar works means:** "Experience contractors have completed the following job successfully for Civil Maintenance /Labour Supply works for any work/ sanitation and drain cleaning work.
5. Party should be MII class 1 local supplier. The minimum local content to qualify as a class 1 local supplier is denoted in the bid document. All bidders must upload a certificate regarding the percentage of the local content along with their bid, failing which the bid is liable to be rejected.
6. Party should have geographic presence in Jharkhand. The party should have office at Jharkhand and party should provide the office address in Jharkhand with contact and email address.
