- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

1. Pre-Qualification Criteria (PQC)

The Qualifying Criteria for this tender are as follows. The bids of tenderers which do not fulfil the Qualifying Criteria shall be summarily rejected.

A) Experience Criteria

Experience of having successfully completed similar jobs during last 07 years including current fin ancial year in which application are invited should be either (a or b or c) of the following:-

Bidder shall submit the work order copies along with work completion certificate as a pr oof of supply of the manpower as mentioned above. Bids without completion certificate are liable to be rejected.

Note1: Bidders who are having a valid MSME certificate in the field related to "manufacturing/ supply/services shall be exempted from above criteria (GeM/ ATC with experience, financial criteria, tender fee, EMD).

B) Financial Criteria

Bidder must have achieved an average minimum financial turnover of **Rs. 23.00** Lakhs or more d uring last seven financial years ending on 31.03.2023 (i.e., FY 2020-21, FY 2021-22 & FY 2022-23) including Profit & Loss A/c statement for (FY 2020-21, FY 2021-22&FY 2022-23) audited balance sheet with UDIN provided by the auditor, necessary undertaking (if any) etc. along with technical bid.

2. SCOPE OF WORK

The scope of work under this tender will be generally as per specifications, Schedule of quantities and general conditions of Contract and as directed by Engineer-in-Charge on behalf of UCIL. Howe ver the major work is described as follows:-

- · Housekeeping and sanitation work of all the buildings and utility areas etc.
- · Cleaning of all toilets/bath rooms at all the specified areas
- · Cleaning of roads
- Collection of debris/garbage including disposal of the same at respective nearby dustbin
- · Cleaning of windows, doors at regular intervals
- · Cleaning of floors including mopping and wiping with water mixed with phenol/liquid soap regularly on day to day basis
- The above jobs are to be carried out at Tummalapalle Plant area/Mines area/UCIL C olony/UCIL Hospital/SPF Barracks complex and any other areas as decided by Engin eer-in-charge

The above jobs are to be carried out at Tummalapalle Plant area/ Tailing pond area and any other areas as decided by Engineer-in-charge

Responsibilities of (Semi Skilled Worker in supervisor category who should hav e minimum qualification of 10th Std. or above):

- · The supervisor must follow up the working progress from the contract workers on daily basis.
- He should ensure that all the workers should have to wear the Personnel Protective Equipmen t's
- · Arrangement of the manpower (USW) in all areas wherever absentee is noticed with minimum requirement and for deployment of manpower on public holidays if necessary.
- · Gate passes, maintenance of worker's attendance and other jobs as assigned by EIC.

SPECIAL CONDITIONS OF CONTRACT

3. **PENALTY:**

Failure to maintain the minimum attendance of the workman by the successful bidd er, Company is liable to impose the penalty. The penalty shall be imposed as follows:

The contractor shall maintain Average attendance of 610 Man days of workmen altogether (Including Skilled, Semiskilled & Unskilled workmen cadre) on every running month.

- a) No Penalty shall be deducted from monthly bill when 100% and greater or equal to 90% of average attendance is maintained.
- b) 1% of Invoice amount shall be deducted from monthly running b ill when less than 90% and greater or equal to 75% of average att endance is maintained.
- c) 3% of Invoice amount shall be deducted from monthly running b ill when less than 75% and greater or equal to 60% of average att endance is maintained
- d) 5% of Invoice amount shall be deducted from monthly running b ill when less than 60% of average attendance is maintained.

Special instructions to bidders on penalty:

I. Penalty will not applicable on Sundays and paid holidays.

4. Completion Period:

12(Twelve) months from the date of commencement of work. (Date of commence ment of work will be reckoned as per GEM order).

- 5. The eligibility will be decided strictly based on documents submitted at the time of receipt of tenders. No additional documents be allowed to be s ubmitted after receipt of tenders but there is no bar to seek clarification o r authentication of submitted documents. However in case of poor respon se, with a view to increase the competition, admission of additional documents to meet the
 - a) PQ-Criteria may be allowed subject to the condition that
 - a. "Poor response" implies when less than three bids are fo und suitable on the basis of submitted eligible documents as per NIT.
 - b. The additional documents should not be issued subsequent to last date of receipt of tender as mentioned in the NIT

6. Security Deposit:

Total amount of Security deposit shall be limited to 10% of the awar ded value of work. Fifty percent of this amount shall have to be deposited as initial security deposit at the time of execution of agreeme nt including the amount deposited as Earnest Money. In addition to the above, further amount to the extent of the 5% of awarded value of the work will be deducted from the Running Account bills by way of percentage deductions. Such percentage deduction shall be @ 10% of the running account bills till the full amount of security deposit is realized/retained by the Corporation.

- 7. <u>Defects Liability Period:</u> Not applicable.
- 8. **Refund of Security Deposit:** 100% of security deposit will be released after comple tion period.

9. **Variation:**

Any individual item may vary up to any extent subject to gross variation of maximu m \pm 10 % (ten percent) of contract value. Contractor is liable to execute above variation at the same rate, terms and conditions stipulated in the contract.

10. Extension:

Completion period of contract is **12(Twelve)** months from the date of com mencement. The tenure/period may be extended up to **03(Three)** months (if the contract value is not consumed completely due to unforeseen reasons) further after completion of initial contract period with same rate, terms & con ditions of the contract with mutual consent, if so deemed fit by UCIL and agreed by the contractor, as the nature of awarded work is as and when required basis and at discretion of the Engineer-in-charge

11. <u>Escalation:</u>

Escalation Clause is only applicable on the "Prevailing Min. wages and its related co mponents like Min. Wages, EPF, Bonus, overtime payment & any other statutory co mponents only" and shall be reimbursed on actual basis subject to documentary evi dence of latest Central. Govt. /State Govt. Circulars on Minimum wages.

12. Payment terms:

The contractor shall submit monthly bill along with the work details completed by th em on prescribed form in duplicate to the Engineer-in-Charge (EIC) after distribution of wages to the deployed manpower. The bidder should give the details of his bank account in the prescribed E-banking format to facilitate payment through e- bankin g in case of award of work on him. As per provisions contained in statutory Labour /l ndustrial Laws, copy of wage sheet, wage slip, PF and ESIC latest challans should be enclosed with the monthly bills. Payment will be released after satisfactory completi on of the work or event (in case of continuous supply of services) in all respect and certification by the Engineer In charge, UCIL within 30 days of submission of tax in voices(s) in original + duplicate 2 (two) copies as prescribed under rule 1 of invoices rules subject to the provision of adjustment of dues and statutory deductions as app licable. Contractor shall issue tax invoice (s) after the provision of service within 30 days from the date of certification of work or event, & also mention work order no., date as well as name of work and actual date of commencement of work or event, s howing the description, value, tax charges thereon and such other particulars as pr escribed as per GST Act, 2017 invoice rule in their every invoice(s).

a The bidder should get the labour license for supplying of manpower as per our requirement mentioned in NIT, before commencement of work k or within one month after commencement of work.

bAge limit for unskilled and semiskilled manpower must not be more than 55 years.

13. Indemnity:

Contractor will fully indemnify the corporation against all responsibility, any c osts or expenses (including legal costs on an indemnity basis) and Claims of contractor's workmen in respect of personal injury or death or loss of, or dam age to or interference with, any other property (whether real or personal), thi rd party or to corporations' personnel and properties. Contractor shall abid e by all the necessary provisions of various other Labour Laws/Acts viz. ESI/Bonus, Workmen's Compensation, EPF and any other laws and rules applicable, in this regard. If on account of non-compliance with the provisions of any laws, Corporation is called upon to make any payment to or in respect of his employees, the service provider shall fully reimburse to Corporation for all such payment and Corporation shall be free to make deductions on this account from the amount of Performance Security Deposit and retention money.

14. Insurance:

The contractor shall obtain necessary insurance coverage till the arrangemen t of ESI for each deployed worker as per statutory requirement. The copy of i nsurance to be furnished to UCIL.

15. Variation in schedule of quantities (or) Total amount:

Any Schedule of quantities (or) Total amount may vary up to any extent subject to gross variation of maximum \pm 10 % (ten percent) of contract value. C ontractor should agree and liable to execute above variation at the same rate , terms and conditions stipulated in the contract.

16. <u>Labour Licens:</u>

If applicable, necessary Labour License shall be obtained by the contractor for the workman engaged at site at his own cost which shall be reimbursable on submission of documentary evidence. The Labour License shall be required to be obtained for the whole period of the contract and shall be furnished to the corporation before commen

cement of the work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the General Terms and Conditions/सामान्य नियम और शर्तें, conditions stipulated in Bid and

<u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्तें is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
