Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band defined in relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.

4. Only such firms need tender who can produce satisfactory evidence that they have the necessary experience & financial resources and organization to undertake such work as per criteria mentioned below.

i) The Tenderer's average annual turnover for the work during last 03 years, ending 31st March of the previous financial year, should be at least 30% of estimated value i.e. 10.37 Lakhs in Audited balance sheet & profit & loss account of each year must be submitted by the tenderer.

ii) Experience of having successfully completed for "Manpower supply". during last 07 years ending last day of month previous to the one in which application are invited should be either of the following

One single similar completed job costing not less than 80% of estimated value i.e. 27.64 Lakhs or
