SCOPE OF WORK

The scope of work per shift under this tender is as follows:

- 1.1. To operate various unit operation and unit processes like Horizontal Belt filters, Precoat filters, Ion Exchange Unit, Precipitation unit, Drying Unit, Uranium Peroxide Plant, Tailings plant, Limestone, Water Treatment plant, etc.
- 1.2. To look after and maintaining the operational parameters, Shift wise report writing in log sheets and logbooks is required on day to day basis in jadugoda mill and WTP.
- 1.3. The job involve supervision and to instruct helpers for washing and spillage lifting of slurry, filters, tank draining and de-scaling ,pipes jam cleaning and de-scaling, etc., or another miscellaneous job directed by the Engineer- In Charge by following safety parameters.
- 1.4. To assist mechanical & electrical persons as & when required to make the HBF ,Precoat filters, Ion-Exchange unit , Precipitation unit, Drying unit, Uranium Peroxide plant, Tailings plant, limestone plant, Water Treatment Plant ready and as per direction of Engineer-in-Charge,Shift incharge or their representative.
