1. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

3. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

4. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

5. Generic

Buyer Organization specific Integrity Pact shall have to be complied by all bidders. Bidders shall have to upload scanned copy of signed integrity pact as per Buyer organizations policy along with bid. [Click here to view the file](#)

6. Generic

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

7. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

8. Inspection

9. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. **Pre-Qualification Criteria:**

- a) Bidder should be lubricant manufacturer i.e. M/s IOCL, M/s HPCL, M/s BPCL only
 - b) Bidder shall confirm that they have offered the items as per the specification or their respective grade as mentioned in tender.
2. Period of contract: 365 days from the date of contract.
 3. Make: IOCL / BPCL / HPCL only.
 4. Deviation of order quantity: Up to +-10% variation in the execution of purchase order of the total order value for sanctioned order value is allowed without issue of amendment/revision in the purchase order.
 5. Delivery Schedule: Delivery of the material will be made within 25 to 30 days from the date of written intimation received from our concern stores department Last supply request should be raised before 30 days from the date of expiry of tenure of contract so that execution should be done within the tenure of contract.

6. Splitting of quantity: To ensure smooth supply, efforts will be made to split the quantity on L1 (Lowest) and L2 (2nd Lowest) bidder in the ratio of 60% and 40% respectively, subject to matching of L1 bidder's rate by L2 bidder. However, in case L2 bidder does not match L1 bidder's rate then the same opportunity will be given to L3 bidder to match L1 bidder's rate and so on. If none of the bidder agree to match L1 bidder's rate then order for 100 % quantity will be awarded to L1 bidder. Opportunity of price matching request will be given to all the parties on single time as per GEM

However MII and GEM splitting rules shall prevail over the said splitting clause and subsequent to price bid opening and during the time of splitting of order quantity, option allowed by GEM portal for splitting of quantity shall be applied and binding to the participated bidder.
